

Hands Belong On Ladder Rungs, NOT ON SIDE RAILS!









3 POINTS OF CONTACT MUST BE MAINTAINED AT ALL TIMES WHILST ON LADDER



Level I "Authorized Person" Training

"Authorized Person" — An individual who has the approval of their employer to perform duties at a location where they will be exposed to high angle fall hazards. (ANSI Fall Protection Code Definition 2.11)



(ANSI Fall Protection Code Definition 2.30)



(d) Personal fall arrest systems.

(20) The employer shall provide for prompt rescue of employees in the event of a fall or shall assure that employees are able to rescue themselves.
